The Waterbrook Art Exhibition was conceived for the promotion and encouragement of the Arts within the surrounding community and to create a greater sense of community involvement in art.

The 2015 Waterbrook Art Exhibition is co-ordinated in conjunction with Oatley 101 Society of Artists Inc. and will be judged by Susie Devenport.

Susie Devenport is a multi talented Sydney based artist. Her association with the Royal Art Society of NSW of which she is a Fellow and Council Member, spans almost 40 years. She is an exhibiting member of Ku-Ring-Gai Art Society, Portrait Artists Australia and a regular exhibitor at the Royal Art Society's Lavender Bay Gallery, North Sydney. Primarily a figurative painter, Susie also paints landscapes. A finalist in the Berkelouw and Shirley Hannan National Portrait Awards she has also been involved in exhibitions which support the Motor Neurone Disease Association of NSW and the Cure Cancer Australia Association.

Susie has worked on commissions, received various major commendations and awards over the years and is represented in collections both overseas and locally.

The official opening and presentation of awards will take place on Friday 27th February 2015, 2014 from 6pm at Waterbrook Yowie Bay.

CONDITIONS OF ENTRY

- **ELIGIBILITY:** All prizes at the Exhibition are open to all artists resident in Australia. Whilst the Society Prize is for financial members of the Oatley101 Society of Artists Inc. All entrants must be aged 18 years and over.
- **SUBJECT:** All works must be inspired by 'Water'.
- **ENTRIES:** Entries must be the original work of the exhibitor, completed within the previous two years, and not have been entered in any previous Waterbrook Art Exhibition. NO copies, paintings on glass or ceramics, photo-reproductions, computer-assisted works, nor 3-dimensional works will be accepted. The works may be in any medium.
- **SIZE:** Works are not to exceed 400cm total outside perimeter of frame. Small Works are not to exceed 150cm around outside perimeter of frame.
- **AWARDS:** All works are eligible for all prizes except for the Society prize. Only works by members of the Oatley 101 Society of Artist Inc. are eligible for the Society prize.
- **FRAMING:** Works must be dry, properly framed, ready to hang with cord or plastic-coated wire, with no projections or unprotected glass or Perspex edges. Stretched canvas (deep edge only painted on all sides) securely corded. No staples on sides are acceptable. Paintings with screw eyes or bare wire will not be accepted. Any artwork requiring repair or deemed unsuitable for hanging will be rejected and no correspondence will be entered into. No refunds if your work is rejected.
- **NUMBER OF ENTRIES:** Maximum of 2 works per artist. Each unit of a diptych is regarded as a separate entry.
- **HANDLING FEE:** To enter the Exhibition, the handling fee is \$25 per artwork for non members of Oatley101 Society of Artists Inc. OR \$20 for Financial Members of Oatley101 Society of Artists Inc. This is non refundable under any circumstances.
- **SALE:** All works must be for sale. All sales are subject to 25% commission to Oatley101 Society of Artists Inc.
- **GST:** Your GST position must be completed on the Entry Form.
- **HOBBYISTS** must supply a "Statement by a Supplier Form" with the completed Entry form.

• **ACQUISITION:** McGrath Sylvania, will acquire the work winning the McGrath 1st Prize for the prize money only. Brian Smith Solicitor will acquire the work winning the 2nd prize for the prize money only.

• **JUDGING:** All entries will be viewed by the Judge, but not all will necessarily be hung. The Judge's decision is final and no correspondence will be entered into. No refunds for works not hung.

• **ENTRY FORM:** Entry Form and fees to be sent to S Kane, 17 Belgrave ESP. Sylvania Waters NSW 2224 by Tuesday 17th February 2015. Late entries will not be accepted.

• **RESUME:** Artists are encouraged to include their CV (resume) with their Entry Form.

• **IDENTIFICATION:** The artist's name, title of work, medium and price must be clearly marked on the back top right hand corner of each work. Please use enclosed labels.

• **INSURANCE:** Exhibitors are responsible for their own insurance of works. All reasonable care will be taken but no responsibility is accepted for loss, theft or damage while in custody or transit, or for works not collected on Sunday 1st March 2015, after 6pm.

• **PUBLICITY:** Exhibitors shall allow their work to be reproduced for promotional purposes or display, or for use by the media.

• **DELIVERY:** Deliver artworks to Waterbrook, 19 Wyralla Road, Yowie Bay NSW 2228 on Wednesday 25th February 2015, 9am - 4pm. No late deliveries accepted. NOTE: Artworks will not be accepted or returned by postal delivery.

• **COLLECTION OF ENTRIES:** Those not hung may not be collected until the close of the Exhibition. All entries must be collected on Sunday 1st March between 4pm and 6pm. Please bring receipt. Waterbrook Yowie Bay and the Oatley101 Society of Artists Inc will not be responsible for works not collected by this time. Works collected after 6pm on Sunday 1st March, will be charged **\$20 per day late pick-up fee** (maximum 7 days). Uncollected works will be disposed of.

• **INTERPRETATION OF CONDITIONS:** In the event of a dispute regarding the interpretation of conditions, the decision of the Organising Committee SHALL BE FINAL.
